

CityCycle 3 Million Trip Competition Competition Terms & Conditions

1. Information on how to enter the competition forms part of the competition conditions.
2. Entry into the competition is deemed acceptance of these terms & conditions.
3. **The competition period:** The competition commences at 12:00am on Wednesday 21 November 2018 and runs through to Wednesday 19 December 2018 at 11:59pm.
4. **Eligibility:** Entry to the competition is open to all persons who hold a Monthly Membership or Student Monthly Membership, except employees of Brisbane City Council ("Council"), JCDecaux and their immediate family, staff, and staff of companies involved with the production, publishing and administration of this promotion and their immediate family. Immediate family means parents, siblings, spouse, children and grandparents. Entry is NOT open to Casual Pass holders.
5. Entry to the competition is only open to Australian residents over 18 years of age.

6. **How to enter:**
